AB 2448

Effective January 1, 2007

- Reduction of allowable adult ADA to 10% of total ROP ADA by 2010 11
- Removal of the 3% cap on enrollment of students under the age of 16
- Development of CTE course sequences in 90% of the sectors for which both the ROP and local community college offer courses in
- Modification of the Advisory Committee format to an Employee Advisory Board format
- Stipulation that ROP reserve funds are used solely for ROP purposes

Progress in Compliance

- Adult ADA for 2008 09: 23%
 - down from 27% in 2006 07 and 25% in 2007 08
- Enrollment of under age 16 students: 631
 - Increase from 84 students in 2007 08
- Course Sequencing: 93% of courses sequenced with Hartnell and/or MPC
- Use of ROCP funds: In service with District Coordinators and CBOs
- Employee Advisory Boards: Use of expanded agenda
 - Awaiting change to Employee Advisory Committee format

Course Sequencing Plan

- Educational Code Section 52302 (b) (1) On or before July 1, 2008 (due to CDE no later than June 30, 2009) all governing boards of Regional Occupational Centers of Programs (ROCP) are required to develop a plan for establishing sequences of state funded courses, in which both the ROCP and community college offer instruction.
- Furthermore, AB 2448 stipulated that 90% of a ROCP's courses must be sequenced with one or more area community colleges in pathways in which both offer courses.
- Plan to Sequence
 - Submitted to CDE August 22, 2008

Describe Steps to be Taken

- Mission Trails Regional Occupational Program Director Randy Bangs met with Monterey Peninsula College Tech Prep Coordinator and Interim Associate Vice President for Occupational Education
 - Course inventories for MTROP and each of the colleges were completed
 - Each MTROP course was matched with applicable community college courses and programs to determine if a sequence existed.
- à A course sequence is a series of two or more courses (one ROP course and one Community College course) which link to provide a course of study as defined by the Carl Perkins Act for Vocational Education.

Required Indicators

- The Course Sequence Table includes detailed information on each required indicator
- Of the courses which are sequenced with one or both community colleges
 - 76.8% lead to a skill certificate
 - 58.1% lead to high growth/high demand jobs or increase in wages
 - 10.8% meet UC “A G” requirements.

Timeline for accomplishing the sequencing of courses

- September 1 – December 31, 2008: The MTROP director worked with community college representatives to inventory ROP courses, inventory Hartnell College and Monterey Peninsula C Courses and determine common pathways.
- January 2008 – March 31, 2009: The MTROP director worked with community college representatives to develop draft sequencing documents.
- The draft course sequence list was reviewed by the MTROP District Coordinators to assure accuracy verify sequences existed. This list was finalized in March 2009.

Use of State & Federal Resources

- How funds will be used to maximize opportunities for High School Students
 - CalWORKS (California Work Opportunities and Responsibility to Kids) provides funding to provide career technical education to low income adults
 - Carl Perkins Vocational Education Act (VEA) provides federal funds to supplement and enhance career technical education at school sites for secondary students and at ROCPs for adults
 - SB 70 provides grant opportunities to build partnerships between community colleges and ROCPs

Use of State & Federal Resources

- Career Technical Education Community Collaborative Grant in partnership with Mission Trails ROP to support course articulation, teacher externships, professional development and exploratory career technical education for middle school students
- Tech Prep funds, received by community colleges, support efforts to build formalized career pathways between high schools/ROCPs and community colleges.

Strategies to fill in the gaps

- District Coordinators who meet regularly will confer with the community college tech prep coordinators
 - (A) if there is a need to sequence courses in any pathways which are not sequenced and
 - (B) if so, revise existing courses or develop new courses to enable sequencing to occur.
- In addition, advisory committees for both the community colleges and district ROP courses will provide input and advice on the need for sequencing in specific pathways.

State Funded Course Sequencing Plan

Educational Code Section 52302 (b) (1) On or before July 1, 2008 (due to CDE no later than June 30, 2009) all governing boards of Regional Occupational Centers of Programs (ROCP) are required to develop a plan for establishing sequences of state funded courses, in which both the ROCP and community college offer instruction. Furthermore, AB 2448 stipulated that 90% of a ROCP's courses must be sequenced with one or more area community colleges in pathways in which both offer courses.

1. Describe the steps that will be taken to identify state funded courses offered by the Regional Occupational Center or Program, in pathways in which the ROCP and community college both offer instruction. E.C. 52302 (b) (1).

The Mission Trails Regional Occupational Program Director Randy Bangs met a minimum of three times each with Monterey Peninsula College Tech Prep Coordinator Mary Nelson and Interim Associate Vice President for Occupational Education Esteban Soriano between November 2008 and January 2009. At these meetings course inventories for MTROP and each of the colleges was completed. Subsequently, each MTROP course was matched with applicable community college courses and programs to determine if a sequence existed. A course sequence is a series of two or more courses (one ROP course and one Community College course) which link to provide a course of study as defined by the Carl Perkins Act for Vocational Education.

Following the sequencing process with community colleges, the draft course sequence list was reviewed by the MTROP District Coordinators to assure accuracy and verify sequences existed. This list was finalized in March 2009.

2. Include in the plan information on how items listed in E.C. 52302 (z) (1) (2) (3) (4) will be addressed. **Note: It is recognized that not all courses will meet the requirements listed in E.C. 52302 (a) (1) (2) (3) (4).** (Sequence addresses/provides Skill certificates, Prerequisite courses, Occupations/High Wage entry Jobs/Significant increase in wages, and UC "A G" Approved courses).

The Course Sequence Table includes detailed information on each indicator listed above. Of the courses which are sequenced with one or both community colleges, 76.8% lead to a skill certificate, 58.1% lead to high growth/high demand jobs or increase in wages and 10.8% meet UC "A G" requirements.

3. Provide a timeline for accomplishing the sequencing of courses.

A timeline for completing and submitting the State Funded Course Sequence Plan was established in August 2008.

September 1 – December 31, 2008: The MTROP director worked with community college representatives to inventory ROP courses, inventory Hartnell College and Monterey Peninsula C Courses and determine common pathways.

January 2008 – March 31, 2009: The MTROP director worked with community college representatives to develop draft sequencing documents. The draft course sequence list was reviewed by the MTROP District Coordinators to assure accuracy verify sequences existed. This list was finalized in March 2009.

4. Describe how the plan maximizes local, state and federal resources to help high school students enter employment, apprenticeships or postsecondary education. E.C. 52302 (b) (5)

The course sequencing plan is aimed at maximizing the number of students enrolling MTROP and community college classes and providing career technical education training in as many industry sectors as possible. There are several funding resources which enhance this effort. CalWORKS (California Work Opportunities and Responsibility to Kids) provides funding to provide career technical education to low income adults. Carl Perkins Vocational Education Act (VEA) provides federal funds to supplement and enhance career technical education at school sites for secondary students and at ROCPs for adults. The state SB 70 provides grant opportunities to build partnerships between community colleges and ROCPs. Hartnell College is currently operating a Career Technical Education Community Collaborative Grant in partnership with Mission Trails ROP to support course articulation, teacher externships, professional development and exploratory career technical education for middle school students. Tech Prep funds, received by community colleges, support efforts to build formalized career sequences between high schools/ROCPs and community colleges. Hartnell College and Monterey Peninsula College both receive Tech Prep funding. The impact of each of these initiatives is that students identify a career pathway and pursue secondary and postsecondary education and training to enable them to access a career in the area of their interest.

5. Describe strategies which will be used to fill in the gaps in courses identified through the planning process. E.C. 52302 (b) (6)

There a minimal number of ROCP courses which do not sequence with either community college. District Coordinators who meet regularly will confer with the community college tech prep coordinators, who also attend the meetings, to determine (A) if there is a need to sequence courses in any pathways which are not sequenced and (B) if so, revise existing courses or develop new courses to enable sequencing to occur. In addition, advisory committees for both the community colleges and district ROP courses will provide input and advice on the need for sequencing in specific pathways.
