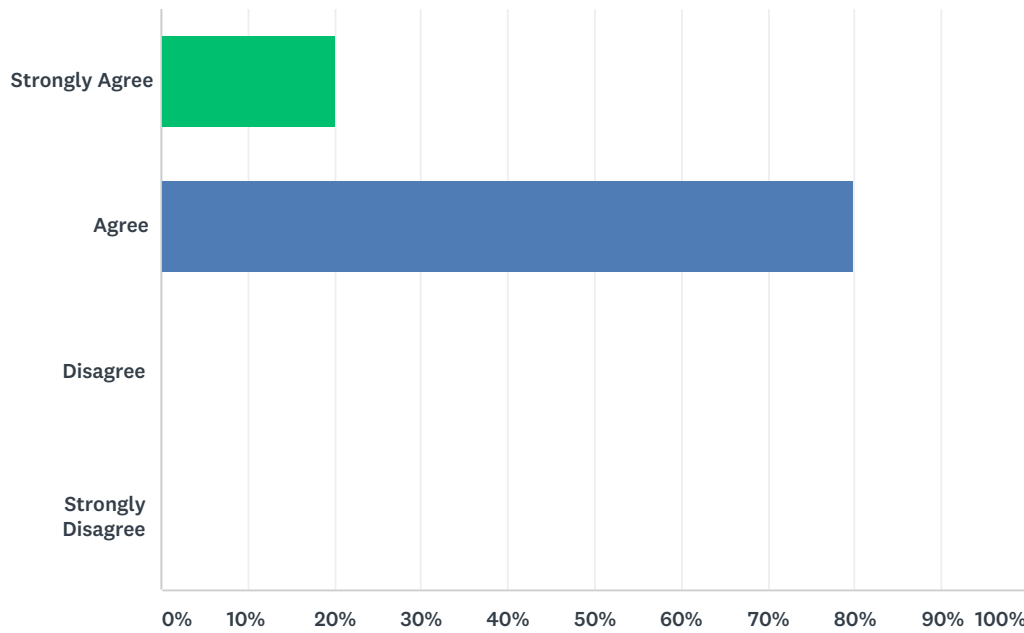

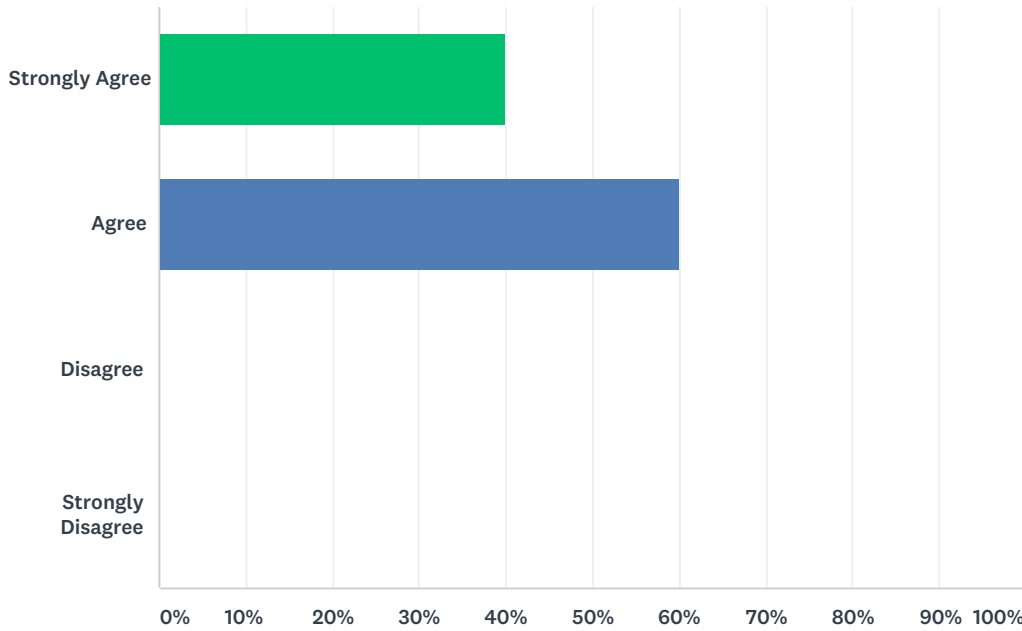

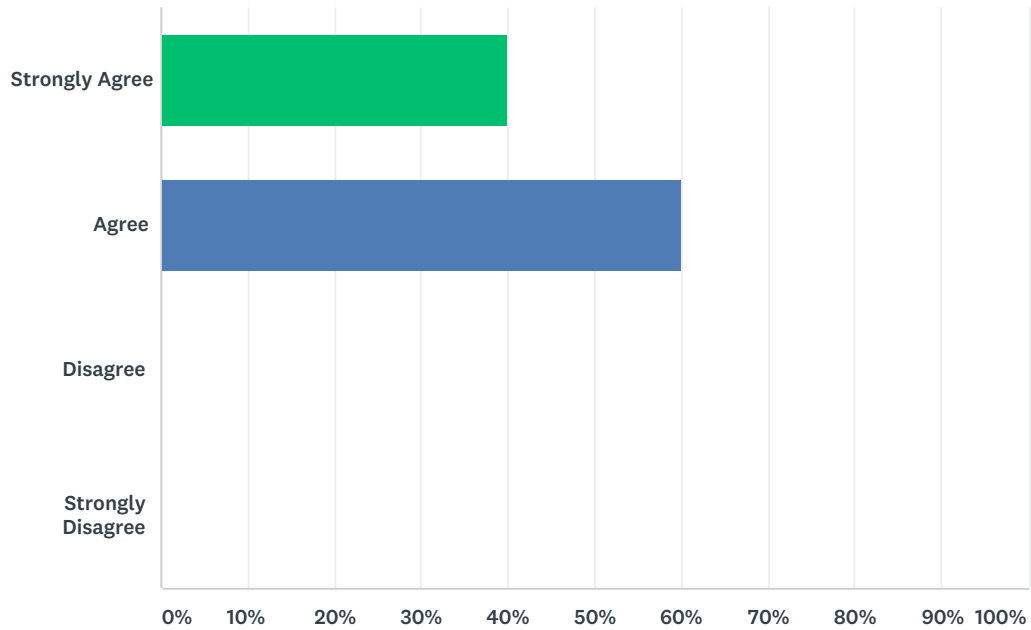

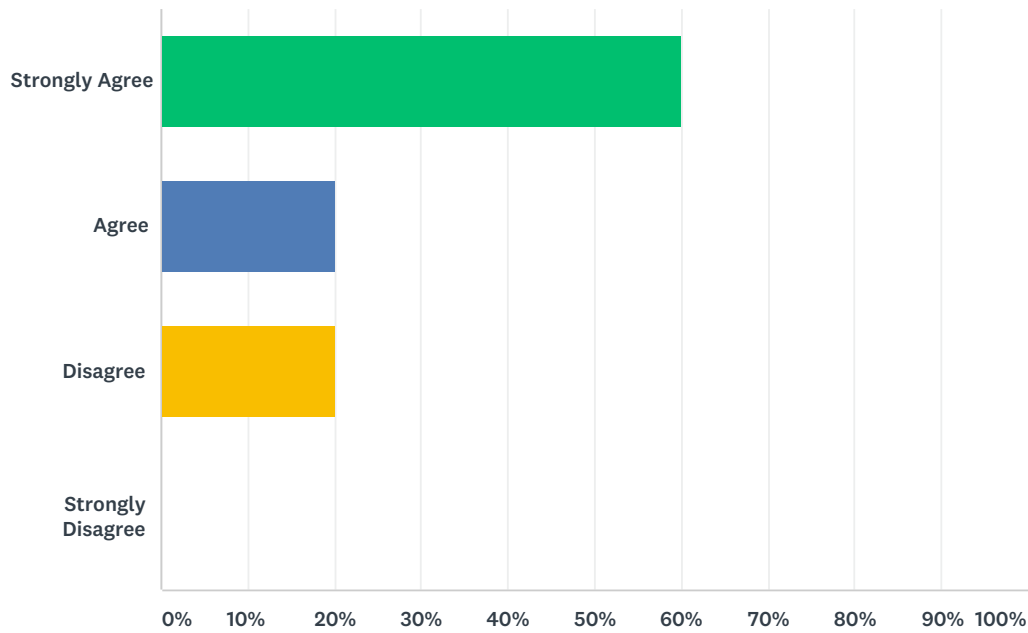

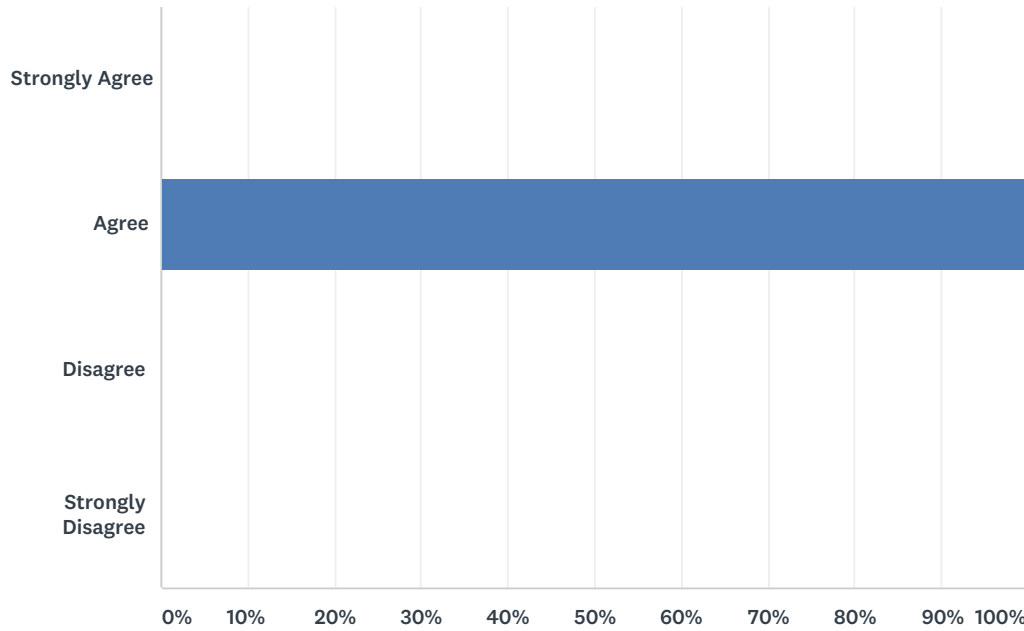

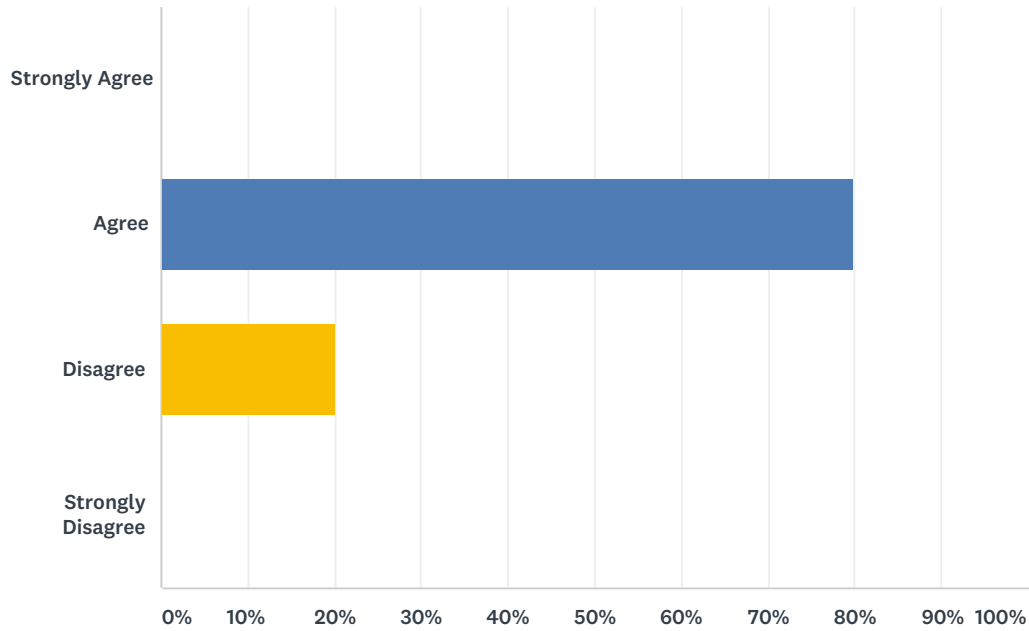

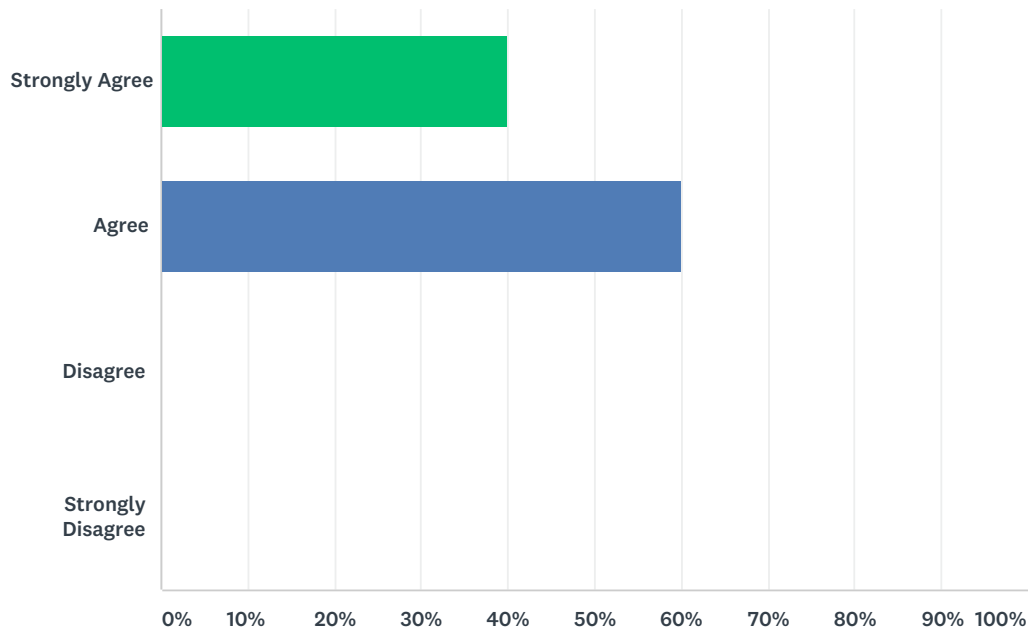

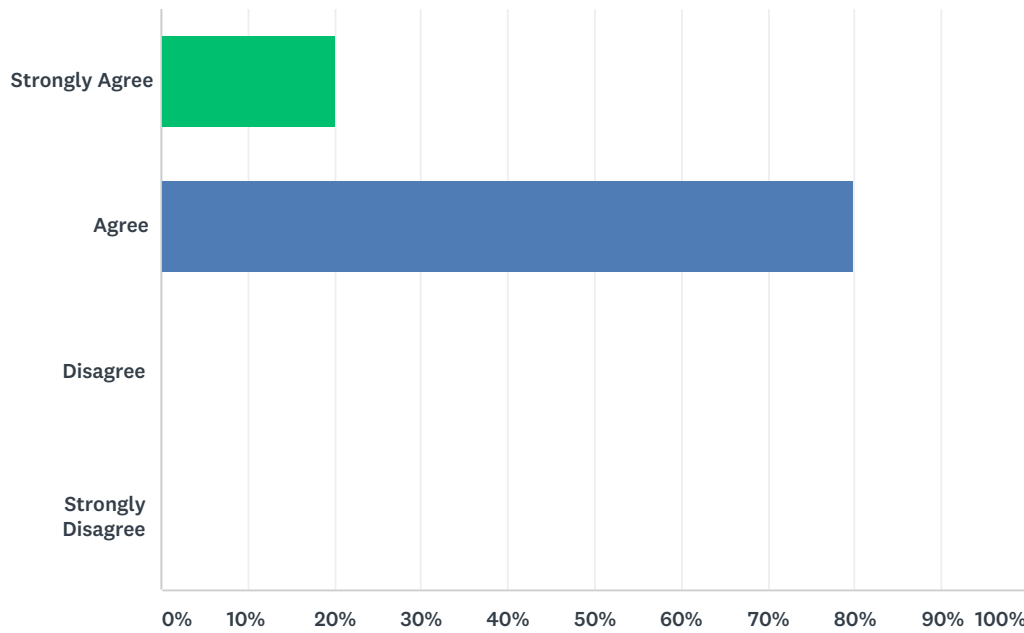

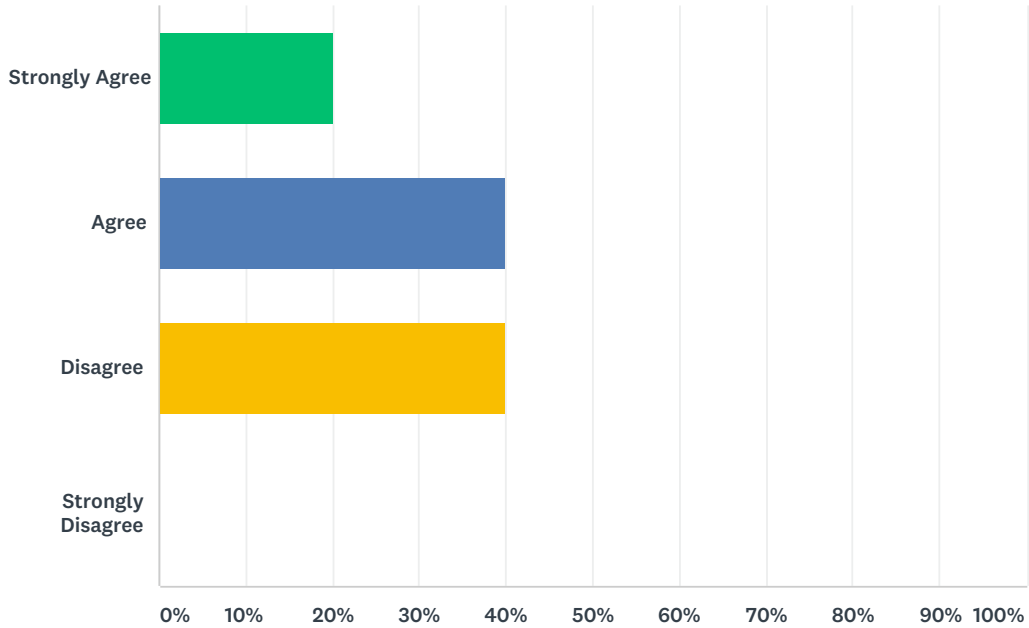

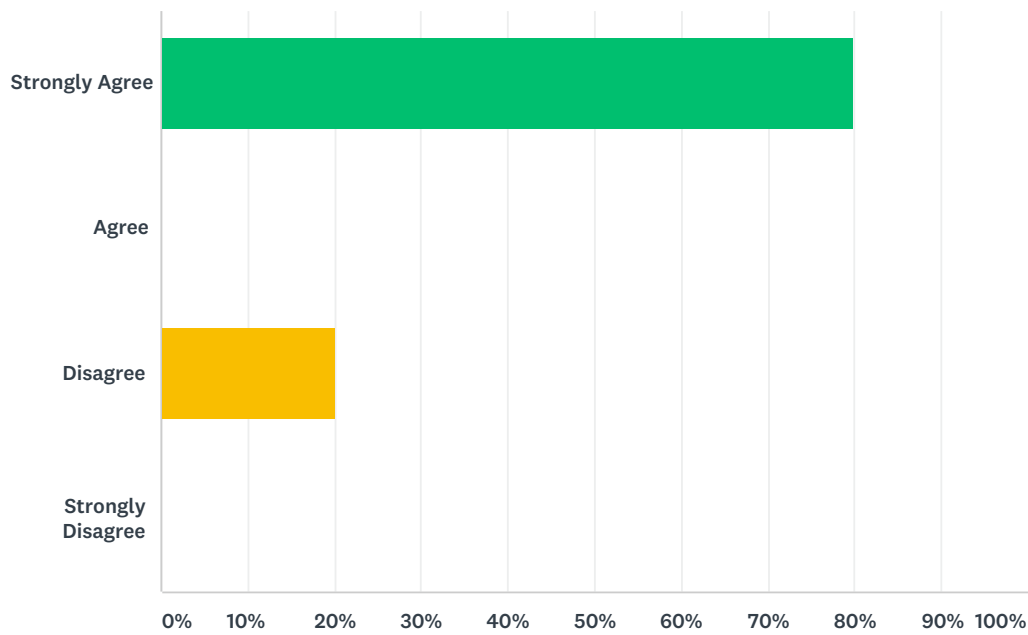

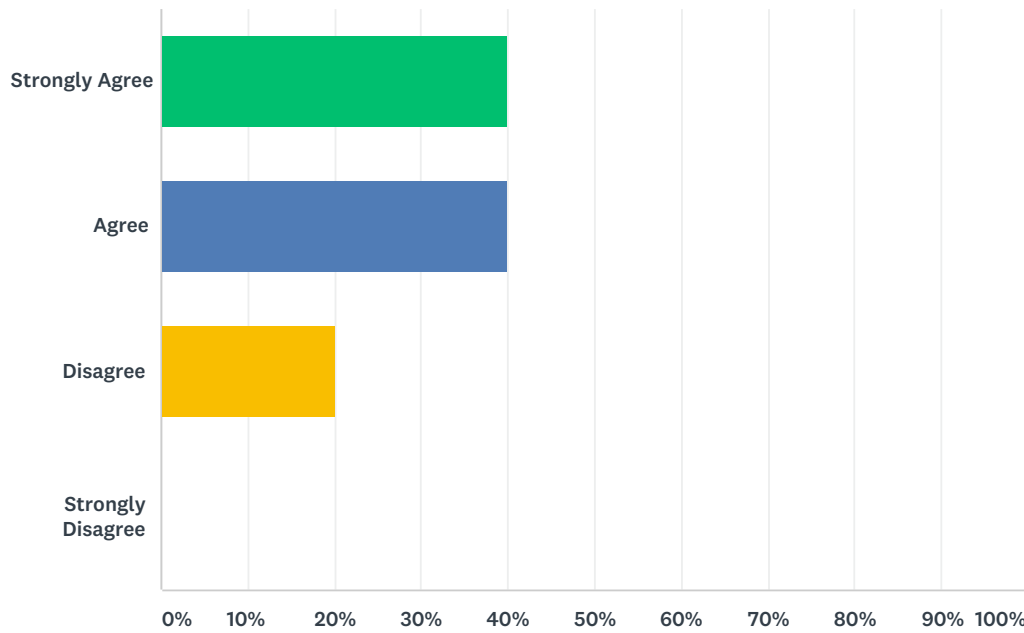

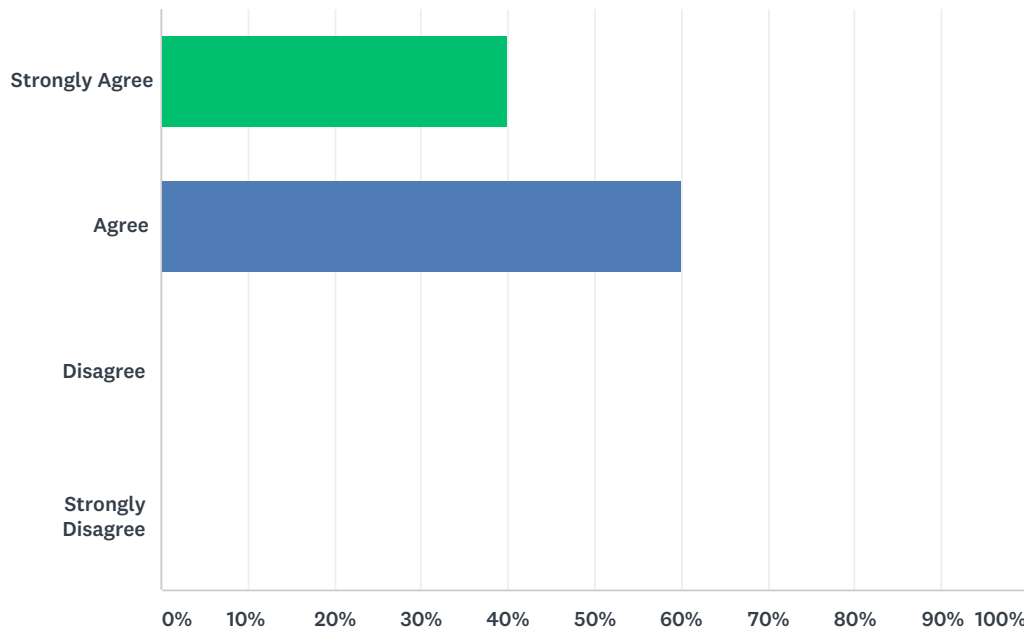

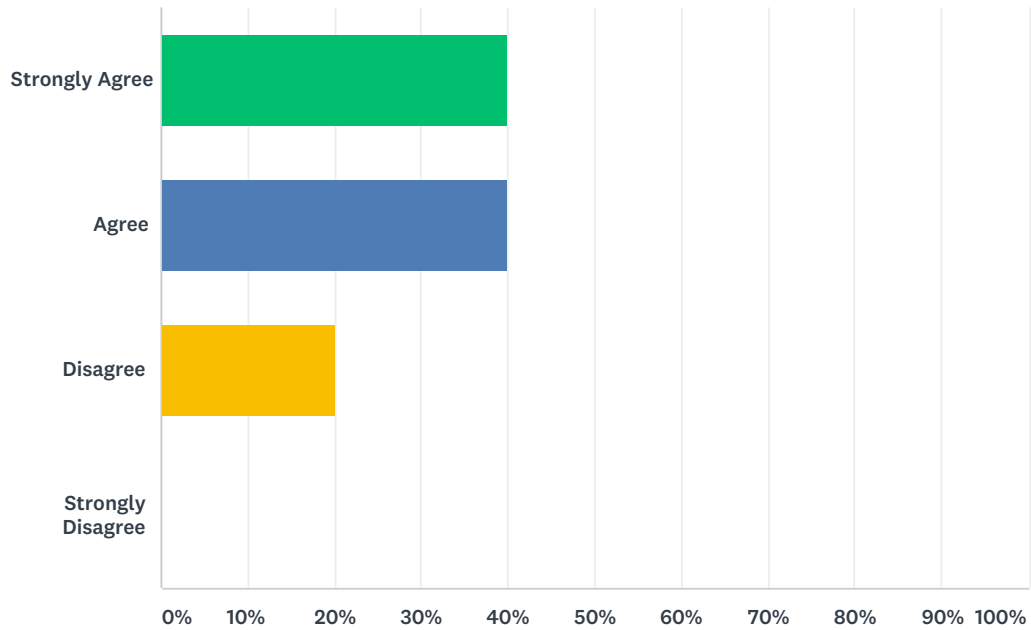

Q15 Different opinions and values were represented.

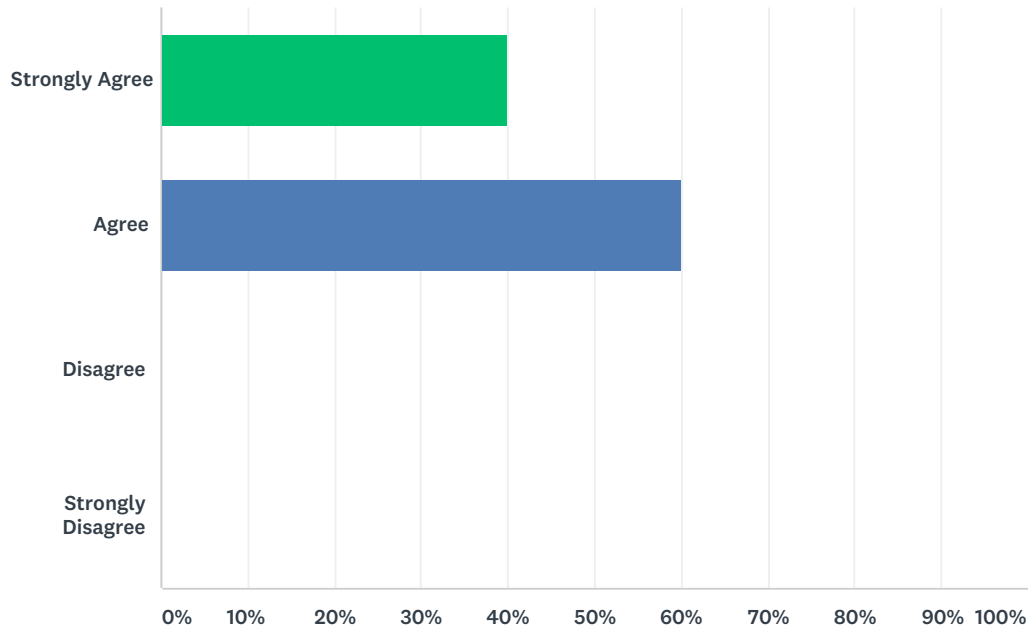

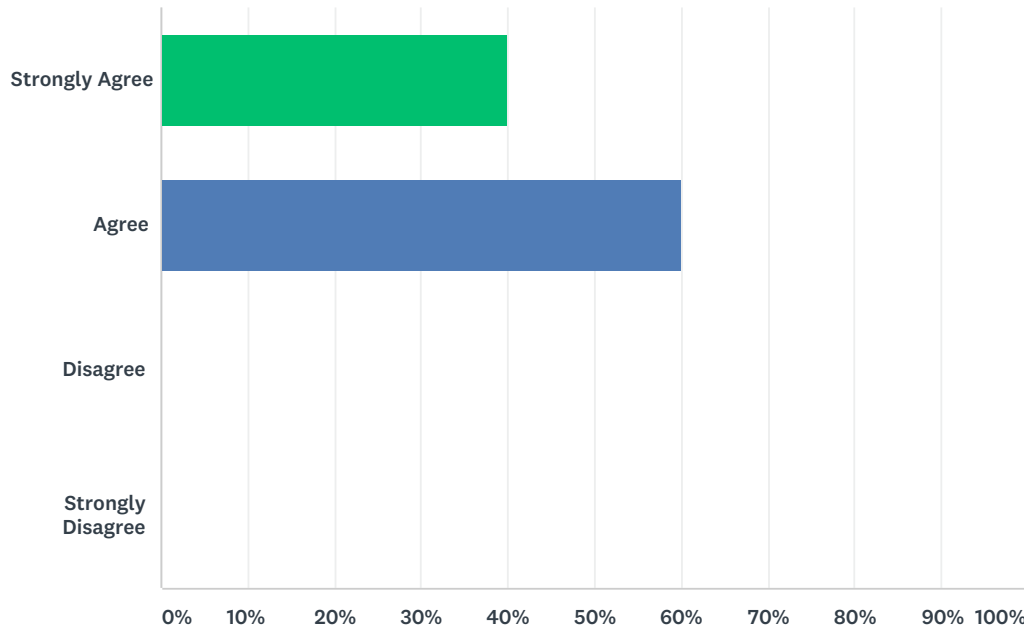

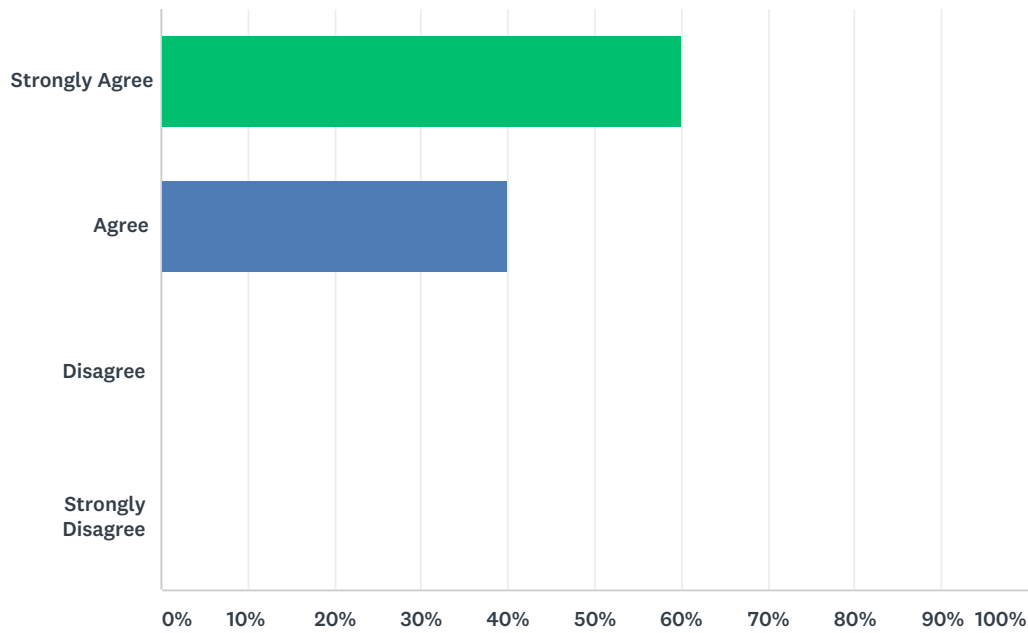

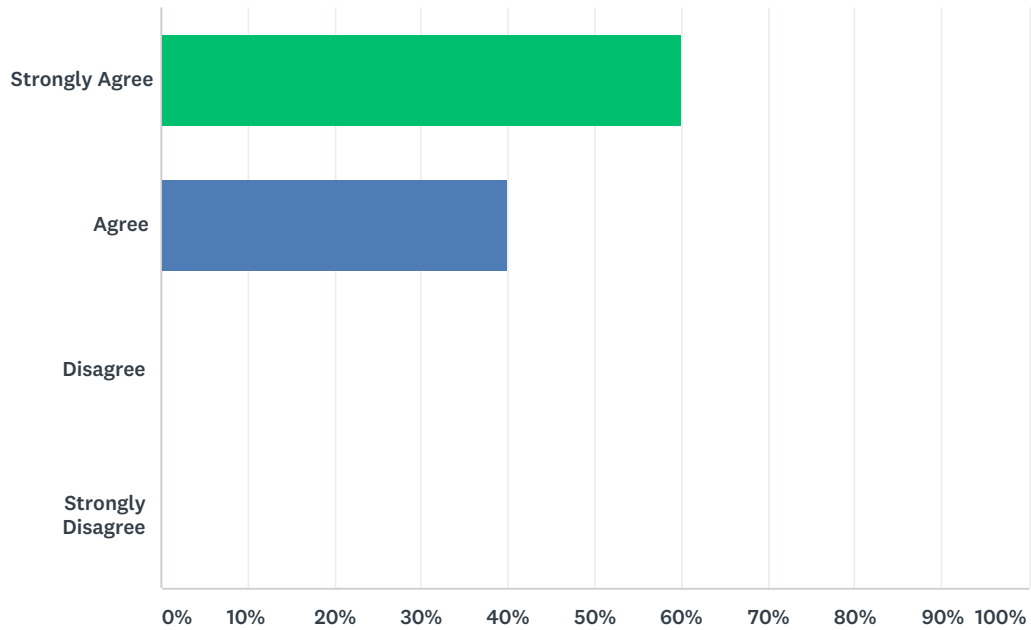
