1. CALL TO ORDER

Michele Peregrin

Meeting called to order at 12:09 PM by Michele Peregrin.

2. CONSIDER APPROVAL OF AGENDA

Approval of October 22, 2020 Agenda

MSC: (Manuel Bersamin/Bronwyn Moreno) October 22, 2020 agenda was unanimously approved.

3. CONSIDER APPROVAL OF MEETING MINUTES

Approval of September 17, 2020, Meeting Minutes MSC: (Manuel Bersamin/Bronwyn Moreno) The September 17, 2020 minutes were unanimously approved.

4. BUDGET UPDATE

David Techaira

David Techaira, Controller presented the budget update; essentially this presentation was given to the board of trustees on 10/6, which was approved.

- FY 20-21 The College has a balanced budget; did not budget approximately \$2M in vacancies; ending the year with a 20% reserve per board policy.
- Personnel 85% attributed to salaries and benefits.
- State deferred payments allocated monies, but funding will not be received until
 next fiscal year. Funding also includes a revenue deficit of \$28M distributed among
 the colleges, Hartnell's share is \$438K no COLA included in this FY budget.
- Hartnell received COVID relief funds in the amount of \$800K.
- Reviewed the budget ending 2019, which ended with a surplus of \$3M.
- Reviewed the capital outlay and development funds (41 and 44) both ended in a positive balance.
- Grants Fund 12 budget is \$30M, which includes 73 grants, 2 local, 9 federal. Largest is HSI and COVID.

Ana Gonzalez asked about salary increases and grants and whether salary increases would be retro and how will it be handled with the grants, especially because the College closed out the grants at the end of the FY.

David explained increases were built in and adjusted to the budget, so there is no retro impact.

Dr. Marnie Glazier asked two questions:

- 1. Related to salary/benefit increase (she was on the bargaining team) she asked for assurance that the retro increases were passed along to classified/staff/custodial staff?
- 1. David confirmed all the groups have a "me too clause". The only group waiting is the CSEA group. There is still negotiation happening, but once completed they will also see the increase.
- 2. She asked about the CARES Act funding sources for students.

David explained there are four revenue streams that address the CARES Act fund – basically the institutional and minority portion can be used for grants to students, supporting transition to distance ed learning, and purchased technology equipment. David encouraged contacting Marina Davis regarding checks. There is a website with information for students who would like to apply to the CARES Act grant.

Jackie Cruz stated she is currently working with David Phillips and David Techaira and there is \$120K ear-marked for hot spots and chrome books, but because the CARES Act funds the College there is a possibility the ear-marked funds may be made available for students who have basic needs issues.

Dr. Marnie Glazier asked if there is a point person that students can reach out to. Jackie mentio nedMarina Reyes, Sergio Diaz or Nancy Reyes. Carla Johnson also replied that students can join a virtual chat and get assistance with the application or have questions answered.

5. GRANTS REPORT/ROUNDTABLE

Michele Peregrin

Michele Peregrin provided the grants report. She stated there was focus on two opportunities related to dual enrollment.

Laurencia Walker – one federal grant, which is a 2-year opportunity, and one privately funded grant, which is a 1-year opportunity.

Clint Cowden stated that with the ABTI strategic plan they are looking for funding.

- Looking at USDA grant to address workforce skills training, scaling the non-for-credit courses, working with a consortium with other colleges.
- Looking at new generation of workers in this time of COVID, upgrade the programs and build on what they are currently doing.
- Working with VETS, earn while you learn in the automotive.
- Working with Grower Shipper Association train the trainer program companies send employees to training for professional development and the employee takes the training back to their companies.
- Working on a grant w/ CSUMB for under-graduate students.

Michele stated there is work being done on a grant for Early Education and Expansion – primarily for equipment to upgrade and improve the playground.

Received a Hewlett grant for The Western Stage and a grant from the Monterey Peninsula Foundation to the support the arts. The Foundation received a grant from the James Irvine Foundation for financial resilience.

Cesar Velasquez said his area is in the process of working on a draft for the Trio Talent Search grant that would provide additional support to Salinas Unified School District. The grant is for approximately \$230,000 for five years.

Mo Yahdi stated that in partnership with UCSC his area is working on a grant to develop more high school and middle school teachers in STEM. Not all of the funds were used last year, so now the process is to find where the funds are needed. The College is working on collaborating together to make sure there is an effort to reach out to students and promote those pathways for teachers in STEM.

Bronwyn Moreno provided a brief update on activities that her office is working on with the help of two grants (the Catalyst fund grant and the grant for formerly incarcerated students from the chancellor's office). Funds are being leveraged and her area is piloting an inclusive fellowship program for students who face barriers to employment. There are faculty mentors who are guiding those students to conduct research projects.

6. COMMUNICATIONS UPDATE

Scott Faust

Scott Faust provided some communications highlights:

- Continuing with the president's weekly newsletter (every other week)- he asked for items. Please continue to send to him.
- Recruitment advertising Hartnell spring recruitment commercial during the baseball game, on-going campaign in Spanish/English, also digital and social and radio. Working on new digital campaign to be used for recruitment but can be adapted to other areas, "Salinas Valley Strong" – adapting the idea for upcoming Giving Day campaign to happen on November 18 using the "Hartnell Students Strong".
- Working with a group to raise awareness of what Hartnell has to offer to high school students, the quality of courses and diverse programs. Developing print materials to share with educators as toolkit. Showcasing high schools and students who decide to come to Hartnell.
- Jackie Cruz opportunity for athletic teams and any department to get engaged in the Giving Day. Donors will designate what departments/groups they want to support. This is a grass roots campaign, to personalize and promote Giving Day.
