1. Recognition of Recently Tenured Faculty Tony Anderson  
 Dr. Jalomo reviewed the recently tenured faculty with the council. The announcement is located on the council website. Mrs. Kimbrough acknowledged the hard work these faculty members accomplished in receiving tenure.
  
2. Survey for Evaluation of Effectiveness Romero Jalomo  
 The council took time to review the survey. The results will be reviewed at the next council meeting on April 22, 2021.
  
3. Presentation: SA Outcomes Romero Jalomo  
 Dr. Jalomo gave a detailed presentation on the Student affairs outcomes. At least 40% of the Student Affairs division is grant funded. 4. Measure T Update Joseph Reyes  
 Mr. Reyes informed the council on the recent Measure T construction developments. The King City project had their last construction meeting this week. The building will be turned over to Hartnell by April 1<sup>st</sup>. There are still equipment that will be transferred to the building soon. Dawn sends out weekly email updates. Her most recent email contained photos of current projects. Soledad is in the final stages of completion. Floor grinding needed to be called back to touch up the floor as it wasn't completed to satisfaction. It is located on 3.8 acres that was sold to the college for \$1. The location also has space for an additional building in the future. On the main campus, work is being completed on the quad, elevator, renovation of the second floor of D, classroom that can sustain up to 60 students. On Building E, they have completed renovation of all restrooms on all 3 floors. They have replaced the elevator on building E. The second and 3<sup>rd</sup> floor will need to wait until the nursing building is completed as well as the renovation of building B. Mr. Reyes stated the goal is trying to not make it difficult for programs and only move them once due to construction or renovation. They are beginning framing on the Castroville building they are looking to open the facility in spring 2022. Furniture design planning has begun at that location. The roof of building C, student center is currently being worked on. There is another week and a half of tarring. It will be about two and a half weeks total for completion of that building. Phase 2 on Building J and K, meetings have begun to go over what is needed in the building renovations and work with architects. The board was approached a year ago by two child development agencies, head start and early childhood development. They are utilizing the old FDA lot to include portables for that project which will be a total of 3 months to complete. Dr. Jalomo asked if there were any plans to renovate the ramp in building J. Mr. Reyes stated the ramp is close to meeting compliance to meeting ADA the . They are exploring the possibility of including an exterior elevator. Elevators are really expensive as they also include maintenance. It is on the list of consideration. On phase 2, measure T bond has another project which includes an additional building at the Alisal campus. That would take a conversation with the board on their plans. 5. MESA Priority Group Registration Request Joel Thompson/  
Mohammed Yahdi

The council reviewed the request for the MESA program to be granted priority registration. The request is located in the council website for review. There are 40-50 students a year come into the program who are new out of the 250 students. at the community college level is a

Chancellor's Office sponsored program designed to support STEM (science, technology, engineering, and math) students to successfully transfer to 4-year universities. To be eligible for MESA, the students must meet the following requirements: be first generation college students, be from low-performing high schools, be Board of Governor's fee-waiver eligible, and be in a STEM major and planning to transfer to 4-year program. MESA is a key program supporting students with challenging backgrounds to complete some of the most difficult majors at Hartnell. Many STEM majors (e.g., engineering, chemistry, etc.) are very sequential in the order of courses student need to take and not being able to get into a certain course can put the student behind a semester or in some cases a full year (for courses only offered once a year). MESA is perfectly aligned with Hartnell College's goals as laid out in the Strategic Plan for 2019 -2024, in which Hartnell College has committed to increasing student success; bolstering partnerships with California 4-year institutions; and guiding students toward rewarding careers. These are strategically aligned with California Community Colleges Chancellor's Office vision for Success & Guided Pathways. The council will review this item and take action at the April 22, 2021 meeting.

6. Institutional Self-Assessment for Equity Romero Jalomo  
The council reviewed the self-assessment. Lluvia recommended cultural sensitivity training. Mrs. Flores will send the survey out in an email for completion.
