August 24 – December 12, 2020

May 12 - 18*	<u>Continuing and First Time Students</u> in good standing and who are fully matriculated <i>PAWS on-line registration only. Available 24 hours a day</i>
May 18*	<u>Panther Prep Students</u> <i>PAWS on-line registration only. Available 24 hours a day</i>
May 19*	Continuing, New First-Time, Returning, and Transfer Students who have <u>not</u> completed: Orientation, and Student Ed Plan OR students <u>not</u> in good academic standing OR exceeding 100 HCC degree applicable units. <i>PAWS on-line registration only. Available 24 hours a day</i>
July 9**	Deadline to pay enrollment fees for students who registered between May 8 – July 9. (subject to change)
July 27*	<u>Concurrent Enrollment (enrolled in K-12 grades)</u> : An approved Fall 2020 Concurrent Enrollment Petition must be on file with Admissions and Records by July 23, 2020. <i>PAWS on-line registration only. Available 24 hours a day</i>
August 13**	Deadline to pay enrollment fees for students who registered between July 10 – August 13. (subject to change)

September 2	Last Day to DROP a full term Fall Class to be eligible for a refund = 10% of course meetings – See Refund Policy
September 4	Last Day to DROP a full semester course with “No Grade of Record”
September 5	Last day to ADD a full term Fall class (an Add Code must be used)
September 7	Labor Day Holiday – College Closed – No Classes
September 10	Last day to petition for Fall 2020 Graduation
September 11	Last Day to petition for an Audit
September 18	Last day to petition for Pass/No Pass grade option
November 11	Veteran's Day Holiday – College Closed – No Classes
November 13	Last day to DROP a full semester course with a “W” grade
November 26-28	Thanksgiving Holiday – College Closed – No Classes
