- IV. Two Reading Items, First Reading, No Action
  - A) New Course, First Reading
    - 1) SOC 8-Sociology of Food, Culture, and Society (3 units)

      This new course will go for review in the subgroups and then come back to the full committee for final approval based on recommendation by subgroup.
  - B) Certificate, First Reading
    - 1) Certificate of Achievement in Business, Front-line Supervisors

The certificate narrative and supporting documents are in the Degree Review Folder. Business department has worked with their advisory committee to create this certificate. Based on potential action by Academic Senate to remove math and English requirements for Certificates, they have included an Excel class that will provide appropriate quantitative skills for these students and not included MAT 106 or ENG 102 as requirements.

- v. Two Reading Item, Second Reading, Action
  - A) Proposed recommendation to Academic Senate to remove minimum math and English requirements from Certificates of Achievement.

Currently all Certificates of Achievement (CoA) are required to include a minimum math and English requirement of MAT 106 and ENG 102. We are one of the few community colleges in the system to have minimum math and English requirements for the CoA. AB 705 required colleges to place students with a goal of transfer directly into transfer level math and English. Currently there is pressure from CCCCO to enroll all students in transfer level math and English regardless of goal. Statements made in CCCCO sponsored webinars have indicated that students with a goal of Certificate of Achievement might one day decide to transfer, so if a math or English class is required by the CoA, it is better to have them take transfer level courses. Since this would significantly change the focus of the math and English required by our CoAs, and could create a barrier to students who weren't interested in taking transfer level math or English, the committee will consider removing the minimum math and English requirements for the CoA. Individual programs would be free to include math and English requirements as appropriate for the certificate, but it would not be required of all CoAs.

The committee discussed the impact that this removal would have on the number of units in certificates. There are a few that will go below the 16 unit level. If this policy is passed by the Academic Senate we should identify those certificates so that faculty can determine if there are other appropriate classes to be added. Certificates under 16 units aren't eligible for federal financial aid.

Also discussed: CTE students can benefit from removing the barrier of a blanket math and English requirement for all certificates. Discipline faculty can decide if the certificate outcomes (PLOs) require math or English skills and include requirements if appropriate.

The Curriculum Committee recommends that the Academic Senate remove the minimum math and English requirements from Certificates of Achievement, MSC.
