MSC: Kimbrough/Moorhouse to approve document with friendly amendments. Jason guided the Senate through the narrative and the two diagrams. A friendly amendment was made/approved (Storm/Locke) that a sentence be added to pg. 7/3<sup>rd</sup> paragraph: "All faculty

members (whether already approved to the council or volunteering from without) must be approved by the Academic Senate. A friendly amendment was made/approved (Locke/Kimbrough) that a sentence be added to pg. 8/7<sup>th</sup> paragraph: "Representatives will be selected by a process of the Associated Students of Hartnell College (ASHC). In the diagram pg. 9 "C.S.S. Faculty Member" in the Technology Learning Support council will be changed to "Any Meta Major rep". Also in the diagram pg. 9, A.V. P. Institutional Research in the Equity Assurance council will be updated to "A.V. P. Institutional Equity, Research, and Effectiveness". Spelling correction in diagram pg. 13 under footnote 1: collegial.

### 4) Information Items

### a) Brown Act and Senate

Jason reported that Academic Senate is under the jurisdiction of the Brown Act. A new report outlining the new rules has been published. Hybrid meetings will still be allowed but Senators will need to post agenda on their doors (either office or home) and their addresses will be posted on the agenda (again, either office or home). #### b) Local Degrees: First Reading

**Kelly Locke** 

Kelly presented the recommendation by the Curriculum Committee. The goal is to align the local associated degree pattern with the CalGETC pattern. Kelly reviewed the changes indicating the addition of Section 8 for Lifelong learning. There was discussion regarding Section 6 which is optional; committee members were concerned about excluding the section and having the pattern jump from 5 to 7. Jason asked if there was any space to require a FYE class. Kelly mentioned the possibility of a graduation requirement by that the committee hadn't had a conversation yet on the topic. She indicated a broader discussion needs to happen. Kelly also mentioned the next step about deciding which classes will go in each section. This will require some disciplines to reduce the number of courses offered.
