#### 1. CALL MEETING TO ORDER

Co-Chair Cheryl O'Donnell called the meeting to order at 3:07 p.m. without quorum. The Council agreed to move to information items.

### 2. APPROVAL OF AGENDA

## 4. ADMINISTRATIVE PROCEDURE 4022, COURSE APPROVAL

The Council received revised AP 4022, Course Approval. Dr. Wilkinson highlighted the revisions. Since there was no quorum, the Council did not take action to recommend approval to the superintendent/president; however agreed the AP would return to the May 18, 2022. Cheryl noted that the revised document was vetted per AP 2410, Board Policies and Administrative Procedures, and that the Curriculum Committee reviewed the proposed revisions, also.

### 5. COLLEGIALITY IN ACTION VISIT

Cheryl and Dr. Crow shared that they contacted the Statewide Academic Senate and California Community College League to request assistance in facilitating a participatory governance workshop on June 21, 2022. The workshop is planned for a Governing Board development meeting and is open to everyone. Additionally, plans are to schedule the same workshop in the fall.

#### 6. CTE EMPLOYMENT OUTCOMES SURVEY RESULTS

Dr. Brian Lofman and Dr. Layheng Ting, Office of Institutional Research, provided an overview of the CTE Employment Outcomes Survey results for years 2019, 2020, and 2021. The survey is a statewide study, which assesses employment outcomes of students who have participated in career technical education coursework at California community colleges. Overall, the results are positive in that, over the last three years, Hartnell has either remained the same or improved, and has outperformed statewide in most aspects of the CTE employment outcomes. The results and sources are in the presentation posted on the Council's webpage.
