

## FY 2024-25 RESOURCE REQUEST PROCESS: FUNDING SUMMARY

### Overview:

At the conclusion of the FY 2024-25 Resource Request process, which included requests submitted by departments on September 2024, the Administrative Services Office received approximately \$6 million worth of both on-going and one-time requests from across the college. Following table summarizes the requests received across all major divisions of the college:

### Funding Summary:

Due to budget constraints, the College will not be approving any on-going requests at this time. However, the college, will utilize multiple funding sources to fund one-time requests. In total, the Administrative Service's Office received \$3.6 million in one-time requests. Approximately \$3.6 million of these requests have been tentatively approved, pending confirmation of funding availability. Following is a summary of one-time requests received and funded by major college divisions:
