

K-16 Collaboratives is part of the state of California's broad funding strategy





Grant Program Goal: Help California's economy recover from the COVID-19 pandemic while addressing long-standing social and economic inequities in higher education and workforce preparation


\$18 million to:

- Form a regional collaborative of K-12 institutions, UCs, CSUs, and CCCs
- Establish a steering committee that includes at least 25% employers
- Commit to participating in the Cradle to Career Data System
- Implement at least four 2021 Recovery with Equity Recommendations
- Create occupational pathways in at least two of the following:
 - Healthcare
 - Education
 - Business Management
 - Engineering or Computing

K-16 Education Collaborative Grant Timeline




K-16 Education Collaborative Grant serves as a **convergence point** for building more equitable and effective education-to-workforce pathways

Living Wage 1 Adult: \$40,070


Living Wage 2 Adults + teenager: \$66,530



Graduation Rate and Graduates Meeting UC/CSU Requirements 2020-2021



Establishing a K-16 Collaborative



It starts with a common agenda

This means coming together to collectively define the problem and create a shared vision to solve it.



It establishes shared measurement

That means tracking progress in the same way, allowing for continuous learning and accountability.



It fosters mutually reinforcing activities

That means integrating the participants' many different activities to maximize the end result.



It encourages continuous communications

That means building trust and strengthening relationships.



And it has a strong backbone

That means having a team dedicated to aligning and coordinating the work of the group.



K-16 Collaborative Planning Activities

June – October 2022

- Engaging partners from across the region
- Establishing a process for selecting a backbone or intermediary organization
- Articulating research questions and data sharing needs
- Submitting a planning grant application, including Letters of Support from partner institutions



K-16 Collaborative Planning Activities

November 2022 – September 2023

- Identify backbone organization to lead planning and implementation
- Identify high-value occupational pathways and Recovery with Equity Strategies
- Conduct equity analysis and qualitative research to identify strengths and pain points along current pathways
- Develop implementation plans and measurable outcomes for building pathways
- Outline budget, sustainability, implementation, and continuous improvement plans
