3. Measure T Update Joseph Reyes
Mr. Reyes shared the updates on several Measure T projects. He stated the completion of the King City education center, Soledad center, Castroville and quad area and 2nd and 3rd floor of building D. What is left to complete in the first phase is the second floor of Building B and the second and third floors in Building E. On Phase two, building J and K are both in DSA under review. There were committees that were formed and design drawings reviewed. The plan is to start either J or K in the Spring of 2023. The practice athletic fields is also planning to get revised. The goal is to break ground in the summer of 2023 on the athletic fields. The secondary effects of Building B renovations to expand the counseling offices. Phase 3 is the renovation of F, G, and H. The final building is Merrill Hall, pending funding. Ms. Kimbrough asked what happens to the programs in J and K. Mr. Reyes stated they would need to relocate as available. It will be a 10 month project to complete building K. The main concern in building J is relocating the ceramics program. It would take about a year for that project. Dr. Jalomo asked about the ramp in building J. Mr. Reyes stated the landing spots on the ramp would need to be improved. Please contact Mr. Reyes at jreyes@hartnell.edu with any questions.
4. Umoja Program and Village Update Victoria Coleman
Ms. Coleman informed of the new Umoja Village which was opened yesterday. Umoja is a community of educators and learners committed to the academic success, personal growth and self-actualization of African American and other students. The opening of the Umoja Village provides a space for program students to gather.
5. COVID Protocols for Use on Campus Louann Raras
Ms. Raras shared the new COVID protocols which are located on the council website for review. She introduced Ms. Miriam Contreras who handles the student vaccination and exemption forms. She also helps with the workers compensation side as it relates to COVID. In January the protocols for COVID self-quarantine changed. She stated that if an employee informs that they were exposed to COVID or are experiencing symptoms, the employee should send an email to covidnotifications@hartnell.edu. That email will prompt an auto response email with instructions to follow. If someone has been vaccinated and bolstered you are free to come to campus due to close contact without symptoms.
