3. Student Parent Survey – Qualitative Results

Dr. Jimenez reviewed the PowerPoint presentation posted on the council's website. The presentation displays the journey that lead to the Hartnell College Student Parent Club and the Student Parent Survey. Dr. Jimenez informed the council that student parents make up 26% of U.S. undergraduate students. The majority of the student parent population are women (71%). About 2 million students, or 43% of the total student parent population are single mothers. The majority of student parents who are matriculated at community college are mothers of color. Student parents at the community college have been most dramatically affected by the decline of childcare from 53% in 2003-2004, to 46% in 2013 with less than half of all two-year campuses offering campus child care services. Four focus groups with 13 student parents were conducted in the summer of 2017 and 2018. The result of the survey was that student parents had difficulty navigating the educational pipeline, balancing multiple identities and demands, and childcare challenges.

The mission of the Hartnell College Student Parent Club is to provide the student parent population opportunities for personal, professional, and academic development and growth through self-care and emotional support. The club meets bi-weekly.

4. San Jose State Impaction Changes

Ms. Del Real reviewed the PowerPoint presentation posted on the council's website. Ms. Del Real stated that an undergraduate major or campus is designated as impacted when the number of applications received from fully qualified applicants during the initial filing period exceeds the number of available spaces. Such majors or campuses are permitted to use supplementary admission criteria to screen applications. San Jose State University proposes for the fall 2019 admission cycle to prioritize local residents by adding 0.25 GPA bump when making admission decisions whereas our previous GPA bump was 0.2. Their proposed admissions area expansion included Alameda, Contra Costa, San Francisco and San Mateo counties for transfer students and Santa Cruz for first-time freshmen. This means all those counties will now have priority above Monterey County students. Dr. Lewallen wrote a letter to San Jose State requesting the reconsideration of Monterey County.
