REQUEST FOR GROUP PRIORITY REGISTRATION CONSIDERATION

CRITERIA FOR EVALUATING REGISTRATION PRIORITIES (NOTE: Requests for Priority Registration are limited to Priority Group 2 or 3)

1. The student group is identified through legislation or regulatory provision as being entitled to priority registration.
2. The student group must participate in a college-sanctioned activity that significantly contributes to the mission and strategic priorities of the college.
3. Priority registration is necessary for the student group to maintain eligibility for the college-sanctioned activity.
4. Priority registration has been identified as a strategy to improve access and success for a particular student group.
5. Priority registration is utilized as a means of recognizing or rewarding a particular student group as a result of service or achievement.

NOTE: Cohort/learning community groups are exempt from applying for this process.
