

Removal of Learning Disabilities Assessment from support services & instruction.

LDS assessment is still available, one current counselor is trained/completing certification. The other is taking course work, we are flying the position. The turnaround time for certification (6 months with specialized qualifications to 1 year+) creates vulnerability in the event of turnover.

# Title 5: Learning Disability Definition & Components

A persistent condition of presumed neurological dysfunction which may exist with other disabling conditions. The dysfunction is not explained by lack of educational opportunity, lack of proficiency in the language of instruction, or other non-neurological factors, and this dysfunction limits the student's ability to access the educational process.

To be categorized as a student with a learning disability a student must meet the following criteria through psycho-educational assessment verified by a qualified specialist certified to assess learning disabilities:

- (a) Average to above-average intellectual ability; and
- (b) Statistically significant processing deficit(s); and/or
- (c) Statistically significant aptitude-achievement discrepancies





## Intake Screening & Eligibility Record

- First, and most important, step in process
- Student to complete Intake Screening & Eligibility Record (ISER)
  - Experiences, strengths, specific challenges
  - Medical/health history
  - External factors impacting learning
- Weigh data, consider info available, determine to test or not
  - Assessments are not always the most supportive option

Removal of Tutoring Services from support services & instruction.

DSPS does not currently provide tutoring services and per section 56000 services shall not duplicate services or instruction which are otherwise available to all students. DSPS is working in collaboration with the PLL to build capacity in universal design for learning, academic accommodations, scaffolding & other strategies for supporting students receiving DSPS services.

Inclusion of additional information in: Student Rights & Responsibilities

Additional language to specify code of conduct requirements, access to other facets of student life, and record keeping procedures.

#### Behavior Issues

#### **Follow Due Process!**

 Make sure whatever process is in place is closely followed. Be sure to cover student rights and responsibilities, both for any academic adjustments and for any suspension of services. Ensure that students understand their rights.

#### **Best Practices:**

- Work with your College Disciplinarian and problem solve for best outcome (interactive process)
- Be careful when or if withdrawing Academic Adjustments
- Suspension of Services (show at intake) and Student Conduct Contracts Services cannot be
  entirely canceled, but they can be temporarily suspended until a student completes specified steps
  to reinstate services.
