6. Priority Registration Update

Dr. Martinez informed there will be a BP coming next academic year. Now that we are moving into a year log schedule, it changes things for Priority Registration. Now that students are able to register at any time, title V regulates that it is not necessary for priority registration to be given three times a year. She is currently talking to other colleges with yearlong schedules and impacts to their areas in order to update the BP.

7. BP/AP 5610 – Voter Registration

Ms. Cowden shared the college had a BP but not an AP. The council recommended changing verbiage that the link to the California Secretary of State Office and Monterey County Elections Office will be available on the Hartnell College student registration system (PAWS) should be changed to the website only and remove from PAWS. Ms. Salgado recommended adding it to Canvas. Ms. Cowden updated to include the satellite campuses into the policy.

8. BP/AP 5500 – Student Conduct

Mr. Gutierrez shared that with the retirement of the Director of Student Life, student conduct and student discipline was reviewed and it was determined that the designation for the director would be a conflict of interest. It was also decided to move that responsibility to the Vice President of Student Affairs.

It was also discovered the need of professional development for staff and faculty on how to deal with conflict so it can be resolved at the first point of origin. If it can't be resolved at that point then it should move on to the formal process.

Dean Cowden mentioned it felt that he was on their side now they feel cornered and she suggested training to provide student advocates. There were suggestions that ASHC include positions or their student workers could assist. Mr. Jimenez suggested he can provide training to student workers in their onboarding. Ms. Moorhouse also suggested including Administration of Justice students to assist or be assigned as advocates. She also asked about tracking students and seeing patterns on repeat offenders. Mr. Gutierrez shared the Advocate system currently holds and tracks reporting and will see all reports on that student.

Mr. Gutierrez shared Dean Johnson has taken on the responsibility as the student conduct officer. She has been working on streamlining the Advocate reporting system. She has found revisions and changes that may need to be made that she will share that with the new Vice President of Student Affairs.
