



SPECIAL ASSIGNMENT POSITION DESCRIPTION

Salinas Valley Promise (SVP) Lead Course Developer & Faculty Mentor For the 2020-2021 Academic Year (1 Open Position)

DESCRIPTION OF PROJECT, WORK, AND/OR SERVICE REQUESTED:

SVP Lead Course Developer will be responsible for the development of an online version of the COU 21 course to be implemented in Fall 2020. SVP Lead Course Developer will collaborate with SVP Community of Practice Leaders to develop and implement a training to prepare SVP Faculty Mentors for online teaching and learning. SVP Lead Course Developer will work with the SVP Community of Practice Leaders to develop equity based practices for delivering online delivery of the Counseling 21 course, as well as develop student success workshops to be implemented in Fall 2020 and Spring 2021 to support the first-time, full-time students in the Salinas Valley Promise Program.

SAMPLE DUTIES AND RESPONSIBILITIES:

1. Develop online activities (discussions, projects, videos, etc.) to enhance community building and engagement of students enrolled in COU 21.
2. Develop and lead implementation of a professional development training, to take place in July 2020, to develop equity based practices for teaching and learning in online environments.
3. Lead the community of practice with other counseling instructors to refine strategies for virtual delivery of course activities based on existing curriculum and COU 21 course outline. The community of practice will meet weekly during course implementation and monthly thereafter.
4. Develop, schedule, and assist in the delivery of supplemental virtual workshops for SVP program participants to be implemented in Fall 2020. Examples include: educational planning workshops, SMART Goal setting, time management, etc.
5. Faculty teaching counseling course in support of SVP will be responsible for tracking a cohort of students throughout the year, providing additional follow up services and utilize technology to help track student progress towards meeting SVP requirements and goals.
6. Participate in training as needed to utilize instructional technology and virtual student support platforms effectively.

DELIVERABLES EXPECTED:

1. Development of COU 21 Canvas Shell enhanced with inclusive, interactive, and community building activities that can be implemented in an equity focused online learning environment.
2. Development of professional development training, to take place in July 2020 (exact dates to be determined), in collaboration with the Course Developers.

3. Lead at least four community of practice meetings beginning in August 2020.
4. Development and implementation of a Salinas Valley Promise program mentor survey that will be used for continuous improvement.

DESIRED QUALIFICATIONS AND KNOWLEDGE:

1. Must meet the minimum qualifications to teach courses within the Counseling discipline.
2. Demonstrated commitment to supporting student success.
3. Knowledge of equity based retention strategies and pedagogical practices.
4. Experience teaching online and providing engaging instruction to students from diverse backgrounds.
5. Ability to use technology to deliver instruction and monitor and track student success and retention.

TERMS OF APPOINTMENT:

1. This is a temporary assignment for a period of up to one year.
2. Compensation will be an \$8,000 stipend for the entire project.
3. Monthly time and effort reports are required to be submitted to and be discussed with supervisor.

APPLICATION PROCEDURES:

1. Submit a brief letter of intent that specifies your interest in and qualifications for the assignment. (Max. 1 page). Clearly state your experiences using technology for teaching and learning. Also explain why you are interested in working with students in the Salinas Valley Promise program.
